(3) An external advisor provided sub-advisory services for these funds for the period July 1, 2004 to May 31, 2007.

(4) Benchmark returns are a blend of the Mercer Passive Index (to December 31, 2007) and the neutral weightings of the respective FGP Balanced Funds from December 31, 2007 forward.

(5) Formerly known as FGP Enhanced Yield Corporate Bond Fund, which was launched on January 15, 2013. Historical performance from June 30, 2003 to March 31, 2013 is based on the High Yield Fixed Income Composite. From April 1, 2013 onwards performance is based entirely on the Fund.

(6) FGP Long Term Bond Fund was launched on January 2, 2014. Historical performance from August 31, 2008 to January 31, 2014 is based on the Long Term Fixed Income Composite. From February 1, 2014 onwards performance is based entirely on the Fund.

(7) Benchmark returns are a blend of the FTSE Canada Corporate BBB Bond Index (to December 31, 2016) and the FTSE Canada All Corporate Bond Index from December 31, 2016 forward.

(8) FGP Core Plus Bond Fund was launched on October 31, 2017. Historical performance from December 31, 2015 to October 31, 2017 is based on the Core Plus Mandate. From October 31, 2017 onwards, performance is based entirely on the Fund.
